EXTENDED TRIPS - If you wish to extend the duration or dates of your travel insurance, please contact Campbell Irvine for a quotation. Provided you have paid the appropriate premium to cover the full duration of your entire extended itinerary, then all costs paid for flights, accommodation and excursions would be covered under the cancellation section of the policy subject to the standard policy terms and conditions.

BICYCLES - are specifically excluded from the cover granted under a travel insurance policy.

AGED 66 YEARS OR MORE - Double the standard rates apply for persons aged 66 years or more at the time of taking out insurance. There is a maximum age limit of 74 years old at date of payment of insurance premium (limited to 69 years for annual multi trip policies) unless agreed by the insurer.

PLEASE NOTE - Cancellation cover starts immediately after your application and payment is received. Please note that this insurance specifically excludes the cost of any medical treatment incurred in an insured person's country of residence.

CHILD REDUCTION - Premiums are reduced by half for children aged 18 years or less at the time of payment of insurance premium if travelling with an adult insured under this scheme.

ANNUAL MULTI TRIP - Cover is available for annual multi trip policies, please contact Campbell Irvine for a quotation.

NEW FOR COVID-19

Medical Expenses and Cancellation cover for Coronavirus (COVID-19) included provided you are not travelling against FCO advice.

Medical emergency treatment overseas and medical repatriation if you are diagnosed with Covid-19.

Cancellation cover to reimburse any irrecoverable payments and charges made for travel and accommodation if you have to cancel your trip due to a doctor diagnosing either you, a close relative or your insured travelling companion with Covid-19 and as a result being advised not to travel.

Cancellation due to either you or your insured travelling companion's direct exposure to a close relative being diagnosed with Covid-19 resulting in an order via the NHS Test and Trace programme for you to be medically quarantined and not being able to travel.

Cancellation or Curtailment cover due to denied boarding of public transport if you displaysymptoms of Covid-19.

Please call our medical pre-departure screening helpline on 01702 427 237 to declare conditions. Failure to do so may invalidate your insurance cover. Cover under this policy is only applicable to EU residents.
